New Business:

a: MOU with Zschimmer & Schwartz – The County Attorney presented the Commissioners with a sign MOU from Zschimmer & Schwartz Ivey, LLC Company. Jonathan Jackson with the Development Authority of Wilkinson County explained the Phases of the project. The County Attorney has gone over the contract and is recommending that the Commissioners vote to approve. Motion was made by Commissioner John Williams and seconded by Commissioner Brooks to approve the MOU.
