a: Disposal of Indigent body

The Coroner has notified me that he has an Indigent body that needs to be disposed. There is no next of kin that can be found, it is my understanding that the body can be disposed of by cremation. The County Attorney has informed me that the process involves an affidavit that goes through Judge Cummings, which would allow us to cremate the body. The Coroner has obtained bids for a period of 1 year for burial and cremation. Williams White Column Funeral Home was the low bid of \$1950 for burial and \$900 for cremation. Motion was made by Commissioner Brooks to accept low bid. Motion was seconded by Commissioner Hagins. Commissioner Brooks voted yes, Commissioner Hagins voted yes, Chairman Holder voted yes and Commissioner Howell voted yes. Motion carried there were none opposed.

b: Roll off Truck Bid

Four bids were received to replace the roll off truck that was lost in the fire. Road Superintendent Jeff Smith went to see the vehicles and the best buy determined was a 2014 Mack GU813. It is suggestion to purchase this vehicle in the amount of \$147,665.00. Motion was made by Commissioner Hagins and seconded by Commissioner Brooks to purchase the 2014 Mack GU813 from Gainesville Truck Center, Inc. Commissioner Brooks voted yes, Commissioner Hagins voted yes, Chairman Holder voted yes and Commissioner Howell voted yes. Motion carried there were none opposed.

c: Brewer Road

Motion was made by Commissioner Brooks to put bids out to pave Brewer Road. Motion was seconded by Commissioner Hagins. Commissioner Brooks voted yes, Commissioner Hagins voted yes, Chairman Holder voted yes and Commissioner Howell voted yes. Motion carried there were none opposed.
